Subject:- Letter of Permission to the Joint secretary, Maharana Pratap Education Centre, Sharda Nagar, Kanpur-208024 Uttar Pradesh on seeking permission of the Medical Assessment and Rating Board for Indian system of Medicine, National Commission for Indian System of Medicine to establish a new Ayurvedic Medical College in the name of Maharana Pratap Ayurvedic Medical College, Ishwariganj, Baikunthpur, Kanpur Nagar, Kanpur, Uttar Pradesh, (Inst. ID-AYU0834) with 60 seats in UG (BAMS) course under section 29 of NCISM Act, 2020, from the academic session 2023-24.-reg.

Sir/Madam,

With reference to the subject mentioned above, I am directed to inform you that in pursuance of the provision of National commission for Indian System of Medicine Act, 2020, the Indian Medicine Central Council Act, 1970 (48 of 1970) has been repealed with effect from the 11th day of June, 2021. With effect from the said date, the Central Council of Indian Medicine constituted under sub-division (1) of section 3 of the Indian Medicine Central Council Act, 1970 (48 of 1970) shall stand dissolved. Now, in exercise of the powers conferred by sub-section (3) of the section 1 of the said Act, the Central Government hereby notifies that all the provisions of the National Commission for Indian System of Medicine Act, 2020 has been come into force with effect from the 11th day of June, 2021 and as per regulation 59 (2) of The National Commission for Indian System of Medicine ACT, 2020, Medical standards, requirements and other provisions of the Indian Medicine Central Council Act, 1970 and the rules and regulations made thereunder shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made thereunder. Further, the provision of concerned regulations which are inconsistent with the provision of NCISM ACT 2020 shall not be applicable.

1. I am to refer to your application/ scheme vide ref no. एम०पी०ई०सी०आयु०का०/2022-23/473 dated **29.11.2022 received from the Joint secretary, Maharana Pratap Education Centre, Sharda Nagar, Kanpur-208024 Uttar Pradesh** on the subject cited above and to verify the available facilities of teaching and practical training for **intake capacity with 60 seats in UG (BAMS) course from the academic session 2023-24**, the college was visited on **19.10.2023 & 20.10.2023 on hybrid mode** for issuance of LOI by the visitation team of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) and as per direction of competent authority Letter of Intent was issued you vide letter of even no. dated **01.11.2023** to establish new Ayurveda college in the name of **Maharana Pratap Ayurvedic Medical College, Ishwariganj, Baikunthpur, Kanpur Nagar, Kanpur, Uttar Pradesh, (Inst. ID-AYU0834) for intake capacity with 60 seats in UG (BAMS) course under Section 29 of NCISM ACT 2020 from the academic session 2023-24.**
2. Further, the Medical Assessment and Rating Board for Indian System of Medicine (NCISM) had carried out another inspection of the college on **16.11.2023 and 17.11.2023 through hybrid mode** to assess the available facilities of Teaching, non-teaching, Hospital staff, practical training and other infrastructure facilities available for **issuance of Letter of Permission for establishing a new Ayurvedic Medical college in the name of Maharana Pratap Ayurvedic Medical College, Ishwariganj, Baikunthpur, Kanpur Nagar, Kanpur, Uttar Pradesh, (Inst. ID-AYU0834), with 60 seats in UG (BAMS) course under section 29 of NCISM Act, 2020, from the academic session 2023-24.**
3. Further, in view of above assessment report and all other related documents were assessed in terms of the enforced regulations namely "the Establishment of New Medical College, Opening of New or Higher Course of Study or Training and Increase of Admission Capacity by a Medical College Regulations, 2019, the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016" , provisions under the NCISM Act, 2020 and relevant regulations there under and it was observed that the college is fulfilling the basic eligibility criteria **for establishing a new Ayurvedic Medical College with 60 seats in UG (BAMS) course under section 29 of NCISM Act, 2020, from the academic session 2023-24.** Hence, the President, Medical Assessment and Rating Board for Indian System of Medicine (NCISM), decided to grant Letter of Permission to establish a new Ayurvedic Medical College with 60 seats in UG (BAMS) course from the academic session 2023-24 under section 29 of NCISM

Act,2020, **subject to ratification in the ensuing Board Meeting** of the Medical Assessment and Rating Board for Indian System of Medicine (NCISM).

4. Further, in accordance of the regulation 6 (1) (i) (i), of "Establishment of New Medical College, Opening of New or Higher Course of Study or Training and Increase of Admission Capacity by a Medical College Regulations, 2019, a letter was sent to the college to furnish fixed security deposit vide letter of even no. **dated 20.11.2023** worth **Rupees One crore, for establishing a new Ayurvedic Medical College with 60 seats in UG (BAMS) Course**, in favor of National Commission fund for Indian System of Medicine. In response of the same, your college has furnished the fixed security deposit in favor of the National Commission Fund for Indian system of Medicine through **RTGS/NEFT/UTR. No. HDFCR52023112055518519 dated 20.11.2023 of rupees One Crore transferred by HDFC Bank, Kanpur (for a period of five years) and informed the same vide an e-mail, dated 20.11.2023.**
5. **Therefore, Letter of Permission is issued to the Joint secretary, Maharana Pratap Education Centre, Sharda Nagar, Kanpur-208024 Uttar Pradesh, for establishing a new Ayurvedic Medical College in the name of Maharana Pratap Ayurvedic Medical College, Ishwariganj, Baikunthpur, Kanpur Nagar, Kanpur, Uttar Pradesh, (Inst. ID-AYU0834), with 60 seats in UG (BAMS) course under section 29 of NCISM Act, 2020, from the academic session 2023-24 and relevant regulations thereunder, subject to following conditions:-**
 - I. The college shall submit an undertaking in the form of affidavit duly notarized within one month explaining the details of providing EPF and ESI facilities to the teaching, non-teaching staff of the Colleges/Hospitals and regularly paying the same as per the provisions of Employees' Provident Funds and Miscellaneous Provisions Act, 1952 & ESI Act, 1948 and relevant Rules and Regulations.
 - II. It is further informed that minimum 15% of undergraduate seats of the **permitted intake capacity of 60 seats** shall be treated as all India quota. The counseling for seats under all India quota shall be conducted by respective counseling authority as designated by Central Government for A.Y. 2022-23 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/UT. **The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government/NCISM for all India quota or the students admitted thereunder.**
 - III. It is also informed that determination of fee and all other charges in respect of 50% of seats in private Medical Institutions and deemed to be University should be as per the guidelines issued by NCISM vide ref no. BUSS/Fee/ASU/2022-23 dated 16.09.2022. Fees of the remaining 50% of seats are to be fixed as per the guidelines of Fee Fixation/Regulatory Committee (FRC) of respective State/UT/Deemed to be University.
6. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations thereunder.
7. Further, **as per Sub-section (7) of Section 29 of NCISM Act, 2020**, The Medical Assessment and Rating Board for Indian System of Medicine may conduct evaluation and assessment of any University or medical institution at any time, either directly or through any other expert, having integrity and experience in medical profession, without any prior notice and assess and evaluate the performance, standards and benchmarks of such University or medical institution and if the college is found to be not maintaining the Minimum Essential standards as specified in the concerned Acts & Regulations then **in accordance of Section 28 (1) (f) of NCISM Act, 2020 the issued permission of the college shall deemed to be withdrawn and denial of permission shall be issued by MARBISM for stoppage of admission for that particular academic year or the subsequent year.**
8. Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.
9. **The following requirements should be fulfilled by the college before opening 31st December 2023 and a compliance report should be sent to get permission for the session 2024-25: -**
 - i) All the requirements of the enforced regulations namely "the Establishment of New Medical College, Opening of New or Higher Course of Study or Training and Increase of Admission Capacity by a Medical College Regulations, 2019
 - ii) All the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for undergraduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;
 - iii) All the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Ayurveda);
 - iv) All the requirements under the provisions of the NCISM Act, 2020 and relevant Regulations made thereunder should be fulfilled in to.
10. The College administration will ensure that sufficient qualified teachers and non-teaching staff in the college and requisite staff in the hospital, as per the NCISM ACT and relevant regulation thereunder, are in position before the admission of the first batch of students in the 1st professional of BAMS is made, under intimation to the Medical Assessment and Rating Board, NCISM.

11. The college has to develop the requisite infrastructure for I, II and III professionals well in time as per the norms which will be verified by the medical assessment and rating board and accordingly the permission for taking admissions in subsequent academic session will be considered.
12. The college administration may take up the matter for recognition of the qualification under section 35 of the NCISM Act, 2020 at that time when the first batch of students admitted against this course appears for the first final professional examination of the said course.
13. The fulfillment of the condition given above may be made within the time period specified and compliance report should be submitted by the college to medical assessment and rating board for Indian system of medicine. The medical assessment and rating board for Indian system of medicine will verify that the conditions have been fulfilled for considering the permission matter from the academic session 2022-23.
